1. Contact OUPS to mark underground utilities before starting work.
2. Dig up with excavator to expose sanitary and storm clean-out tees.
3. Replace bot clean-out tees and risers in pvc pipe.
4. Replace problem section of pipe near clean-out tee.
5. Snake and camera both lines.
6. Backfill pipe in stone.
7. Backfill ditch to grade.

NOTE: Price includes cost of plumbing work and excavation work.

OPTION 2: Replace sanitary and storm sewer from front of house to clean-out tees.

1. Contact OUPS to mark underground utilities before starting work.
2. Dig with excavator from front of house to clean-out tees to expose sewer lines.
3. Replace sanitary and storm sewer in pvc pipe and fittings.
4. Make connections from downspout tie ins as needed.
5. Install new clean-out tees and risers for storm and sanitary sewer.
6. Backfill pipe in stone.
7. Backfill ditch to grade.
