Scope Of Work:

HOT WATER TANK:

OPTION 1:

1. Remove and discard existing hot water tank.
2. Install AO SMITH ProLine FCG-75 High Recovery gas water heater.
3. Install tank in emergency drain pan.
4. Install expansion tank.
5. New shut-off valve on cold feed.

COST: \$3,025.00

OPTION 2:

1. Remove and discard existing hot water tank.
2. Install Navien NPE-240A tankless water heater (unit is equipped with a built hot water recirculating pump and 0.5 gallon buffer tank).
3. Install Navien PeakFlowS filtration canister.
4. Install isolation and service valve kit.
5. Install expansion tank.
6. Re-pipe water and gas piping to accommodate tankless water heater.
7. Install flue piping in sch 40 pvc pipe and fittings and terminate to outdoors.
8. Install condensate drain piping.
9. Electrical work as needed.
10. Complete system start-up.

COST: \$4,900.00

ADDITIONAL ADD-ON:

1. NaviCirc crossover valve to provide external hot water recirculation (recommended).

COST: \$150.00

BASEMENT BATHROOM ADDITION:

1. Use camera and locator to locate underground sanitary sewer.
2. Demo concrete as needed for underground plumbing and remove from jobsite.
3. Tie into existing sanitary sewer.
4. Underground DWV in sch 40 pvc pipe and fittings for toilet, shower, and sink.
5. Backfill and cement patch concrete.
6. Above ground DWV in sch 40 pvc pipe and fittings.
7. Install hot and cold water supplies in Type A pex pipe and fittings for toilet, shower, and sink.
8. Rough-in shower valve.
9. Set shower base in mortar bed.
10. Install all plumbing fixtures and make final plumbing connections.

NOTE: This price does not include the cost of plumbing fixtures.

NOTE: This price does not include cost of shower rough-in valve.

NOTE: This price does not include cost of permit.
