2. Install the gas line above drop ceiling through the basement and terminate outside (roughly 50').
3. Trench gas line from where it exits the house to the pool heater location (roughly 40').
4. Install underground gas piping in PE pipe.
5. Install 2 ServiSet risers and brackets.
6. Make connections at pool heater.
7. Pressure and leak test all newly installed gas piping.
8. Paint all exterior gas piping in Rust-Oleum paint.

NOTE: This price does not include cost of permit.
