Scope Of Work:

1. Install Unico 2-2.5 ton R-454B Coil Module.
2. Install Unico 2-2.5 ton Blower Module.
3. Install Unico 2-2.5 ton Return Air Plenum Module.
4. Install RUUD ENDEAVOR 2.0 ton 13.4 SEER2 R-454B condenser on 3" poly pad.
5. Install refrigerant line set.
6. Install main supply trunk and insulate.
7. Install all high velocity air supply tubes (13 outlets total).
8. Install Unico floor outlets (white).
9. Install 30 amp fused disconnect and whip for condenser.
10. Install breaker and electrical wiring for outdoor unit.
11. Install EZ CLEAN condensate trap and condensate drain piping.
12. Install ProStat digital programmable thermostat with new 18-6 thermostat wire.
13. Pressure test new system with nitrogen.
14. Vacuum system to 500 microns or lower.
15. Add R-454B refrigerant as needed.
16. Complete system start-up.
