2. Trench gas line underground to pool heater location.
3. Install 1" PE gas piping underground with tracer wire and caution tape.
4. Install 2 - 1" servi set risers.
5. Make all gas connections at pool heater.
6. Pressure and leak test all newly install gas piping.
7. Backfill ditch.
8. Paint all exterior gas piping with Rust-Oleum paint.
