3. Install sump pit, pump and discharge piping for footer drain.
4. Above ground DWV in sch 40 pvc pipe and fittings.
5. Hot & Cold water supply piping in Type A Pex pipe and fittings.
6. Install PRV and hook up water meter set.
7. Install 2 frost proof hose bibs with shutoff valves.
8. Rough-in tub and shower controls.
9. Install hot water tank or tankless water heater (unit not included in price).
10. Gas piping to all gas fired appliances.
11. Set tubs and shower pans in mortar bed.
12. Install all plumbing fixtures.
13. Make all final plumbing connections.
