3. Install new RUUD RCFY4821STANMC R-454B 4 ton cased evaporator coil.
4. Install new refrigerant line set.
5. Install poly condenser pad.
6. Install new electrical disconnect and whip.
7. Install new condensate drain piping and EZ CLEAN ptrap.
8. Pressure and leak test system with nitrogen.
9. Vacuum system to appropriate micron range.
10. Add R-454B refrigerant if needed.
11. Complete system start-up.
