3. Install new RUUD RCFY4821STANMC R-454B 4 ton cased evaporator coil.
4. Install new refrigerant line set.
5. Install new poly condenser pad.
6. Install new electrical disconnect and whip.
7. Install new condensate drain piping with EZ CLEAN p-trap.
8. Install new 18-2 stat wire from condenser to indoor unit.
9. Pressure and leak test system with nitrogen.

10. Vacuum system to appropriate micron range.

11. Add R-454B refrigerant as needed.

12. Complete system start-up.
