Option 3: Proposal to remove all four existing hot water tanks and replace with three new properly sized hot water tanks and re-pipe all water distribution piping per manufactures instructions.

Option 1:

1. Remove and discard out of service hot water tank.
2. Install new AO SMITH BTH-500A 499,900 BTU commercial gas hot water tanks.
3. Re-pipe as needed.
4. Permit from state of Ohio.

COST: \$22,145.00

Option 2:

1. Remove and discard one out of service hot water tank and one malfunctioning tank.
2. Install two new AO SMITH BTH-500A 499,900 BTU commercial gas hot water tanks.
3. Remove existing water distribution piping for all four tanks and re-pipe per manufactures instructions.
4. Permit from state of Ohio.

COST: \$47,665.00

Option 3:

1. Remove and discard all four existing hot water tanks and water distribution piping.
2. Install three new AO SMITH BTH-500A 499,900 BTU commercial gas hot water tanks.
3. Properly re-pipe all water distribution piping per manufactures instructions.
4. Re-pipe flue piping as needed.
5. Re-pipe gas piping as needed.
6. Re-pipe condensate drains as needed.
7. Permit from state of Ohio.

COST: \$69,800.00

1. New expansion tank.
2. Tempering valve servicing.
3. Tempering valve and piping replacement.
