2. Trench 60' from gas meter to pool heater.
3. Install 1" PE gas pipe underground with tracer wire.
4. Backfill trench.
5. Install 2 - 1" risers (one at meter, one at pool heater).
6. Make necessary gas connections at meter set and pool heater.
7. Pressure and leak test newly installed gas line.
8. Paint all exposed gas piping with Rust-oleum paint.
