5. Install new line set.
6. Install new disconnect and whip.
7. Flue piping in PVC sch 40 pipe and terminate to outdoors with concentric kit.
8. Install new condensate pump.
9. Install new ProStat digital thermostat.
10. Electrical work as needed.
11. Install condensate drain piping.
12. Gas piping as needed.
13. Ductwork as needed.
14. Add R-410A refrigerant as needed.
15. Complete system start-up.
