Proposal to install new RUUD 70k BTU 96% high efficiency 2 stage constant CFM gas furnace with new 2.5 ton air conditioner.

Please note the different options on the SEER ratings for the air conditioner.

The 16 and 14 SEER a/c condensers are back ordered with 10-12 week ship times.

It is recommended by L&A Plumbing-Heating-Cooling LLC to go with the 13.4 SEER2 a/c condenser. Due to our climate it is not cost effective to go with a higher SEER a/c condenser.

1. Remove and discard existing furnace and a/c system.
2. Install new RUUD 70k BTU 96% high efficiency 2 stage constant CFM gas furnace.
3. Install new 2.5-3.0 ton cased evaporator coil and condenser (see options below for pricing).
4. Install new 3" poly pad for condenser.
5. Install new electrical disconnect and whip.
6. Install new ProStat digital multi stage programmable thermostat.
7. Electrical work as needed.
8. Gas piping as needed.
9. Flue piping as needed.
10. condensate drain piping as needed.

11. Add R-410A refrigerant as needed.
12. Complete system start up.
