4. Install tracer wire and caution tape.
5. Install 2 - 1" ServiSet risers.
6. Backfill trench.
7. Make all gas connections at pool heater.
8. Pressure and leak test all newly installed gas lines.
9. Paint exterior gas piping in Rust-oleum paint.
