2. Remove all existing boiler supply and return piping, including manifolds.
3. Install new Navien Combi NCB250/150H High Efficiency Boiler.
4. All new boiler supply and return piping.
5. All new domestic hot water piping.
6. Install Everflow isolation valve kit for domestic hot water.
7. Install Navien NHB-H Primary Manifold Kit.
8. Install Navien Peak Flow-S filtration system for domestic hot water.
9. Install Navien NaviClean Magnetic Filtration System for boiler piping.
10. Install new Viega Supply and Return Manifolds.
11. Install new Navien NHB-H Primary Manifold Kit.
12. Install Tacos electronic external low water cut-off safety.
13. Install external supply and return temperature sensors.
14. Install Navien outdoor sensor.
15. Install 2 Grundfos 3 speed circulating pumps for system and supply.
16. Install Honeywell boiler trim kit.
17. New condensate drain piping.
18. New exhaust and intake flue piping in sch 40 pvc pipe and fittings.
19. Gas supply piping as needed.

20. Electrical wiring as needed.
21. Install new ProStat digital programmable thermostat.
22. Fill and bleed system.
23. Add boiler treatment.
24. Complete system start-up.
