OPTION 1:

1. Remove and discard existing 75 gallon water heater.
2. Install new AO Smith GPVX75L 75 gallon power vent water heater.
3. Install new Zimlet 4.8 gallon expansion tank.
4. Install new shutoff valve on cold feed.
5. Rework water, gas, and flue piping as needed.

COST: \$3,800.00

OPTION 2:

1. Remove and discard existing 75 gallon water heater.
2. Install new Navien NPE 240A tankless water heater.
3. Install isolation valve kit.

4. Install Zimlet 2 gallon expansion tank.
5. Re-pipe water, gas, and flue piping to accommodate tankless unit.
6. Install condensate drain line for tankless unit.
7. Electrical work as needed.
8. Complete system start-up.

1. Navien Peak-Flow S filtration system for tankless unit (recommended).
