3. Install new RUUD Endeavor 2 ton 13.4 SEER2 condenser.
4. Install new RUUD ENDEAVOR 2 ton cased evaporator coil.
5. Install new disconnect and whip.
6. Install new poly condenser pad.
7. Electrical work as needed.
8. Gas piping as needed.
9. New flue piping.
10. Sheet metal work as needed.
11. New condensate drain piping with EZ Clean p-trap.
12. New refrigerant line set.
13. New ProStat T705 digital thermostat.
14. Add R-410A refrigerant as needed.

15. Complete system start-up.
