4. Install new RUUD ENDEAVOR RA13NZ36 3.0 ton a/c condenser.
5. Install new refrigerant line set.
6. Install new disconnect and whip.
7. Install new 2" poly a/c pad.
8. Install new flue piping in sch 40 pvc pipe and fittings.
9. Install new condensate drain piping with EZ clean p-trap.
10. Electrical work as needed.
11. Gas piping as needed.
12. Sheet metal work as needed.
13. Install new Honeywell media cabinet and filter.
14. Install new ProStat 705 digital programmable thermostat.
15. Add R-410A refrigerant to system as needed.
16. Complete system start-up.
