4. Install new refrigerant line set from evaporator coil to outdoor condenser.
5. Install line set in slim duct wall covering.
6. Install new electrical disconnect and whip.
7. Install new A/C poly condenser pad.
8. Sheet metal work as needed.
9. Electrical work as needed.
10. Add R-410A refrigerant as needed.
11. Install new ProStat T701 non programmable digital thermostat.
12. Complete system start-up.
