6. Install new ploy condenser pad.
7. Install new 30 amp fused disconnect and whip.
8. Run new 18-2 stat wire.
9. Install new condensate drain piping with EZ CLEAN trap.
10. Add R-410A refrigerant as needed.
11. Complete system start-up.
