4. Install LG F series High Efficiency 12 MBTU indoor head for four seasons room.
5. Install all refrigerant line sets, condensate drain tubing, and communication wire in Fortress Line set Duct (white).
6. Electrical work as needed.
7. Pressure test newly installed system with nitrogen.
8. Vacuum system to 500 microns or lower.
9. Add R-410A refrigerant as needed.
10. Complete system start-up.
