7. Install new line set.
8. Install new service disconnect and whip.
9. Install new ProStat T701 digital non programmable thermostat.
10. Sheet metal work as needed.
11. Electrical work as needed.
12. Gas piping as needed.
13. Install new flue piping.
14. Install new condensate drain piping.
15. Add R454B refrigerant as needed.
16. Complete system start-up.
