4. Remove and discard existing line set.
5. Install new RUUD 2.5 ton 14.3-15.2 SEER2 R-454B heat pump.
6. Install new RUUD 3 ton R-454B evaporator coil.
7. Install new refrigerant line set.
8. Install new heat pump pad.
9. New EZ Clean ptrap and condensate drain piping.
10. Electrical work as needed.
11. Pressure and leak test system with nitrogen.
12. Vacuum system to appropriate micron level.
13. Add R-454B refrigerant as needed.
14. Complete system start-up.
