7. Install new refrigerant line set.
8. Install new electrical disconnect and whip.
9. Install flue piping in sch 40 pvc pipe and fittings and terminate to outdoors.
10. Install new plenum and takeoff.
11. Electrical work as needed.
12. Gas piping as needed.
13. New EZ Clean ptrap and condensate piping.
14. Install new T705 ProStat digital programmable thermostat.

15. Add R-454B refrigerant as needed.
16. Complete System start-up.
