3. Install new RUUD Endeavor RA1648AJ1NB 4.0 ton 16 SEER R410A air conditioner.
4. Install new RUUD Endeavor RCFZ4824MTANMC 4.0 ton cased evaporator coil medium efficiency.
5. Install new line set, pad, disconnect, and whip.
6. Install new flue piping in sch 40 pvc pipe to outdoors.
7. Install gas piping and condensate drain piping.
8. Electrical work as needed.
9. Install new RUUD ECONET GEN 3 SMART thermostat.
10. Add R410A refrigerant as needed.
11. Complete system start up.
