3. Rough-in above ground DWV for basement bathroom.
4. Install hot and cold water supply piping for basement bathroom in pex pipe.
5. Rough-in owner supplied shower valve.
6. Install owner supplied shower base in mortar bed and install 3 piece wall surround.
7. Relocate basement kitchen sink drain to new location.
8. Install hot and cold water supply piping for basement kitchen sink in pex pipe.
9. Relocate gas line for 1st floor fireplace up into basement ceiling.
10. Relocate water lines up into basement ceiling as needed.
