2. Install sewer ejector pit and sewage pump in crawl space.
3. Install sanitary discharge piping underground to tie into existing septic inlet.
4. Install underground water line from existing house to new building (make proper connections).
5. Install rough water supplies for new building in type A pex for 1 bathroom and 1 utility sink.
6. Install rough DWV in sch 40 pvc for new building for 1 bathroom, 1 utility sink, and 1 floor drain in crawl space.
7. Install Navien NPE 180 A2 tankless water heater in crawl space with isolation valve kit.
8. Install underground gas piping from existing meter to new building.
9. Install interior gas piping for new building for furnace and water heater.
10. Make all final plumbing connections and install plumbing fixtures.
