2. Install 1-1/4" PE gas pipe under ground with tracer wire.
3. Backfill trench.
4. Install 2 - 1-1/4" riser (one at meter, one at pool heater).
5. Make necessary gas connections at meter set and pool heater.
6. Pressure and leak test newly installed gas line.
7. Paint all exposed gas piping in Rust-oleum paint.
