5. Install line set and pad.
6. Install new 18-6 stat wire and new non-programmable digital thermostat.
7. Electrical work to include addition of 30amp 2 pole breaker and 10-2 romex wire for A/C condenser.
8. Install disconnect and whip.
9. Install condensate drain piping.
10. Rework gas piping as needed for furnace.
11. Install new plenum and new filter rack.
12. Add R-410A refrigerant as needed.
13. Complete system start-up.
