OPTION 1:

1. Tie into 1" gas line inside of house in basement.
2. Install 1" gas line through basement ceiling and terminate outside to pool heater location on northeast corner of house.
3. Install 1" tee connection with separate shut-off valve for generator.
4. Make all gas connections at pool heater.
5. Pressure and leak test all newly installed gas piping.
6. Paint all exterior gas piping in Rust-oleum paint.

OPTION 2:

1. Tie into 1" gas line inside of house in basement.
2. Install 1" gas line through basement ceiling and terminate outside on northwest side of house.
3. Trench ditch from northwest side of house to pool heater location behind garage (roughly 75').
4. Install 2 - 1" risers at house and pool heater location.
5. Backfill trench with tracer wire and caution tape.
6. Make all gas connections at pool heater.
7. Pressure and leak test all newly installed gas piping.
8. Paint all exterior gas piping in Rust-oleum paint.
