4. Install new line set from indoor unit to outdoor unit.
5. Install new Slim Duct line set cover on exterior of building.
6. Install new 30 amp service disconnect and whip.
7. Electrical work as needed.
8. Condensate drain piping as needed.
9. Install new ProStat digital programmable thermostat.
10. Rental of 24' material lift.
11. Add R-410A refrigerant as needed.
12. Complete system start-up.
