Proposal to install 3" Double Check Backflow Device on domestic main water line per order of the City of Cleveland Water Department.

This device will need to be installed in a vault which is also part of this proposal.

Scope Of Work:

1. Obtain permit.
2. Excavate vault hole at current main water shutoff location in front of building near compactor/electrical room.
3. Pour concrete base at bottom of hole and install sump pump basin.
4. Cut out existing valve and install new 3" shutoff valve, 3" Pressure Reducing Valve, and 3" Double Check Backflow Device.
5. Set concrete vault in place.
6. Install sump pump and discharge piping.
7. Install electrical conduit and junction boxes for sump pump.
8. Backfill to grade.

NOTE: This price includes the cost of permit and fees.

NOTE: This price includes all labor and materials as well as excavation work.

NOTE: This price does NOT include the cost of electrical work needed to power sump pump (electrician will needed).

NOTE: After installation this Backflow Device will need to be tested and serviced annually per the City of Cleveland Water Department.

NOTE: Water service to building will be shutoff for a full work day.
